PARTICIPATION:

Participants with the Spanish FIDE flag must be federated. Participants with a FIDE flag other than ESP must have a FIDE ID.

TIE-BREAKS:

If two or more players score the same number of points, the tie is to be decided by the following criteria, in order of priority:

1º Direct Encounter.

2° al 5°: After finishing the last round, a draw will be held in the order of application of the following tie-breaks:

- Buchholz Cut 1.
- APRO (Average Performance Rating of Opponents).
- Sonneborn-Berger.
- Most Wins.

6º Most Blacks. Forfeit will be counted as whites.

7º Drawing of lots.

BYES:

3 byes of ½ point will be admitted except for the last three rounds. **1 bye of 0 points** will be admitted. Byes will be requested exclusively from the tournament arbiter.

Requests for byes for round 1 will be made by email to the tournament arbiter (it will appear in info64). The rest of the byes will be requested up to 1 hour after starting the round, in the playing area using the corresponding form. All byes can be requested before starting the tournament.

OTHER CONSIDERATIONS

The non-justified forfeit to a round, or to two rounds, even if justified, will mean the withdrawal from the tournament. Limitation: if the player has already requested a bye of 0 points, he will no longer be able to justify a no-show.

The FACV reserves the right to register and admit players.

The clothing and personal hygiene of the participants will be adequate for a chess tournament, being the organization's authority to expel any participant who does not comply with the instructions received in this regard from the tournament director.

A tournament Competition Committee will be formed, made up of the tournament director and two players.

The pairing will be done with the VEGA program.

The FACV may exercise the right of non-admission to the next open tournaments, such as the one called here, to those players who register and do not appear, as well as those who withdraw without notifying the arbiter, provided that the absence is not duly justified..

It is forbidden to have electronic devices such as mobile phones, tablets, smart watches, etc. in the playing venue. Circular 22/2018 will apply: https://www.facv.org/2018/2018-circular-22.pdf and the FIDE Laws of chess.

In the playing área, it will not be allowed to consume food or have drinks that do not have a cap to avoid spillage.

To receive prizes, you must be present in the playing area at the Closing Ceremony, except for force majeure duly announced in advance and whose justification is accepted by the organization. Failure to comply with this requirement may lead to the loss of prize rights.

Anything not specified in these rules will be governed by the FACV, FEDA and FIDE Competition Regulations or will be resolved by the organization.

PROTECTION PROTOCOL AGAINST COVID:

For these championships the General Protocol against COVID-19 of the FACV is applicable (published in https://www.facv.org), all specific legislation and regulations on this matter and respect the general recommendations given by Health.

The General Protocol is complemented by the specific measures for this tournament described in the Annex of these rules.

The correct use of a **FPP2 mask or higher** is mandatory in the game enclosure, it must be brought by the player himself, as well as a second replacement mask in case there is breakage.

Access to the playing venue will open 30 minutes before to carry out the controls established for the players.

Failure to comply with the measures against Covid-19 can be sanctioned even with expulsion from the tournament.
